ADDENDUM TO VENUE RENTAL AGREEMENT **(Use of Dogs in Wedding Ceremony)**

THIS ADDENDUM TO VENUE RENTAL AGREEMENT (this “Addendum”) is made and entered into by and between Castle Mac-O-Chee, LLC, an Ohio limited liability company (“Mac-O-Chee Castle”), and _____ (“Customer”), to add the following additional terms to that certain Venue Rental Agreement (the “Agreement”) between Mac-O-Chee Castle and Customer having an Agreement Date of _____, with an Event Date of _____ (the “Agreement”).

1. Authorization To Use Dogs. Customer requests, and Mac-O-Chee Castle hereby agrees to permit, Customer to have no more than two (2) dogs at the Event, subject to the following terms and conditions:

(a) Only dogs owned by Customer shall be permitted at the Event. Each dog shall be current on all vaccinations required by law, specifically including, without limitation, rabies vaccinations.

(b) Any dog must be crated at all times, except during the wedding ceremony if the ceremony is outside and the dog is part of the wedding ceremony; and, while the bridal party is being photographed if the photographs are taken outside and the dog is in the photographs. If an outdoor ceremony is relocated inside due to inclement weather, Customer may request, and Mac-O-Chee Castle may approve or reject such request in Mac-O-Chee Castle’s sole discretion, that a dog be permitted to participate in the wedding ceremony and bridal party photographs. Customer will not receive any refund or discount if a dog is unable to participate if the ceremony is relocated from outside to inside.

(c) Crated dogs shall be kept only in indoor or outdoor areas designated by Mac-O-Chee Castle.

(d) Any dog outside of a crate shall be leashed, under the physical control of a handler, and not left unattended. Such dog shall be promptly re-crated upon the conclusion of the wedding ceremony or bridal party photographs, as the case may be.

(e) Dogs shall not be permitted inside the Castle or Manor House under any circumstance. Except for relocated ceremonies as described in Section 3(b), and crated

dogs in designated areas as described in Section 3(c), dogs shall not be permitted inside the Great Hall.

(f) For purposes of this Addendum, the term “Event” shall include Customer’s scheduled rehearsal time on the Thursday immediately preceding the Event Date.

2. Barking; Aggressive/Disruptive Behavior. Mac-O-Chee Castle reserves the right at any time (including, without limitation, before a wedding ceremony) to order a dog be removed, or have a dog removed, from the Venue if, in the sole discretion of Mac-O-Chee Castle, the dog is creating an unreasonable disturbance at the Venue or to the surrounding community (whether by barking or by aggressive or other behavior) or is creating a risk of injury to person or property. Customer shall promptly comply with any request by Mac-O-Chee Castle that the dog be removed from the Venue. Customer will not receive any refund or discount if a dog is unable to participate in the wedding ceremony or bridal party photographs due to removal.

3. Assumption of Risk. Mac-O-Chee Castle hereby disclaims, and Customer hereby assumes, all risks associated with dogs being present at the Event, including, without limitation, death or injury to person or property.

4. Indemnification. Without limiting the generality of Section 18 of the Agreement, Customer assumes liability for, and will indemnify and hold Mac-O-Chee Castle harmless from and against, any Loss arising out of or related to having dogs present at the Event.

5. Proof of Insurance Coverage. Within seven (7) days of Customer’s execution of this Addendum, Customer shall provide evidence satisfactory to Mac-O-Chee in its sole discretion that Customer has homeowners insurance, renters insurance, or other insurance that would provide coverage for liabilities associated with Customer’s dogs at the Event, including, without limitation, death or injury to person or property. If Customer fails to provide such evidence, Mac-O-Chee may, in its discretion, revoke this Addendum, in which case Customer’s dogs will not be permitted at the Event.

6. Definitions. Any capitalized terms in this Addendum that are not defined shall have the meaning assigned in the Agreement.

7. Incorporation by Reference. This Addendum is hereby incorporated by reference into the Agreement. In the event there is any conflict between the terms of this Addendum and the Agreement, the terms of this Addendum shall control.
