Acknowledgment

Mac-O-Chee Castle Wedding & Event Venue is committed to providing every couple and their guests with an exceptional wedding experience. Our Preferred DJ Partners have been trained to operate our venue's specialized audio, visual, lighting, and sound systems. They are familiar with our equipment, venue layout, and operational procedures, which helps ensure a seamless experience throughout your event. Mac-O-Chee Castle receives no financial incentive regardless of the entertainment provider you choose to hire. We have developed our Preferred DJ Partners solely as a commitment to ensure the best experience for our clients and their guests.

While we strongly recommend selecting a DJ from our Preferred DJ List, we understand that some couples may wish to hire an independent DJ.

By signing below, we acknowledge that we have elected to use a DJ who is **not** on the venue's Preferred DJ List.

Understanding of Responsibilities

We understand and agree that:

1. Our independent DJ has not been trained or certified by the venue on the operation of the venue's audio/visual, lighting, or sound systems.
2. The audio/visual system incorporated into Mac-O-Chee Castle Wedding & Event Venue is designed to be a simple, plug and play system. However, we do not guarantee that an independent DJ will be able to fully utilize or operate the venue's equipment, systems, or features. For this reason, we strongly recommend the independent DJ schedules a pre-event walkthrough or equipment check with Mac-O-Chee Castle to further reduce the likelihood of technical problems. The wedding couple is responsible for any additional fees associated with their hired DJ making an additional trip.
3. Even with a pre-event walkthrough, Mac-O-Chee Castle Wedding & Event Venue is not responsible for performance issues caused by or related to the independent DJ's equipment, operation, or familiarity with the venue. Any complications as a result of the independent DJ's performance shall not constitute a breach of the Venue Rental Agreement and shall not entitle us to a refund, credit, discount, or other compensation from the venue.
4. Mac-O-Chee Castle staff may provide reasonable access to available connection points and basic operational information but will not serve as technical support, sound engineers, DJs, or troubleshooters during the event.
5. If the independent DJ's equipment is incompatible with the venue's systems or if the DJ is unable to operate the venue's equipment, the venue is not obligated to modify its systems or provide substitute equipment beyond what is included in the Venue Rental Agreement.

Release

To the extent permitted by applicable law, we release and hold harmless Mac-O-Chee Castle Wedding & Event Venue, its owners, employees, and representatives from claims, damages, losses, or expenses arising from the performance, operation, or technical issues associated with our selected independent DJ or the DJ's equipment, except to the extent caused by the venue's own negligence or willful misconduct.
